The "way home" is different for each person who is homeless.

For some, it is a short path from the streets to return to a supportive family. For others, it is a longer journey to an apartment of their own. Urban Pathways' dedicated staff support and guide homeless men and women by providing comprehensive services and housing that help individuals regain their sense of dignity and make informed choices for their future.

Through our continuum of services, Urban Pathways supports each individual, with many of the people we serve participating in multiple Urban Pathways' programs along their journey toward independence.



STREET SOLUTIONS

Outreach

769 clients served

For many individuals who live on the streets, an Urban Pathways' Outreach Specialist is the first contact they have on their journey toward stability. **Outreach** Teams address the needs of people living on the streets through consistent engagement, practical assistance, case management, assessment, and referral services.

2 Drop-In Center 2,163 clients served

For homeless men and women who have lived on the streets for many years and resist entering the shelter system or long-term treatment programs, the Olivieri Drop-In Center offers 24-hour, on-site services including hot meals, clothing, and showers. When a client is ready to talk with staff, we offer more comprehensive services, including: case management; crisis intervention; referrals to medical, mental health and rehabilitation services: and housing placement assistance. Of the 2,163 clients served, 263 received comprehensive services.

Safe Havens

295 clients served

Many clients find our Safe Havens an effective alternative to large, city-operated shelters. Safe Havens are transitional housing residences with individualized, on-site support services, which prepare clients for the next step on their journey home.

Safe Havens are the cornerstone of our Housing First approach, which recognizes that chronically homeless individuals need a secure place to live so that they can begin to address the scars of mental illness, substance abuse, poor physical health, and other ailments that result from years of homelessness. Once they feel more stable, Safe Haven clients can move on to more permanent housing.

Johnathan's Story

Life in the city can be a tough journey for many people. Johnathan was like others – an unstable childhood, a 30-year history of heroin addiction, arrests and incarceration, homelessness, and long stays in the City shelter system.

But Johnathan's journey took an unexpected turn one day when he heard about Urban Pathways. He liked what he heard about the programs...so in 2015, he said goodbye to his cot in the shelter and hello to a studio apartment in the newly-renovated Cluster House in Manhattan.

Extended-Stay and Permanent Supportive Housing

Our affordable community-based supportive housing features both **Extended-Stay** and **Permanent** programs, which are designed for adults who face multiple barriers to independent living. Program sites include congregate residences with on-site support and scattered-site apartments for individuals who can thrive with less-intensive support services than those found in a congregate residence. All programs promote self-sufficiency and encourage residents' participation in wellness and recovery-focused activities. Our **supportive housing** provides a framework for individuals to create fulfilling and productive futures.

New Residence Alert! Howard Amron House

Our newest permanent supportive-housing residence, the Howard Amron House, opened in July 2018 and provides 10 one-bedroom apartments and one studio apartment to 11 formerly-homeless men and women. Named in honor of a former member of our Board of Directors, the Howard Amron House is located on the Upper East Side of Manhattan and provides residents with independence along with connections to community-based services.



SUPPORTIVE SERVICES

Medical Wellness Program

The **Medical Wellness Program** offers a holistic approach to improve residents' health by connecting them to community-based sources of health care, providing education on health and wellness, and reducing reliance on expensive emergency services and treatment.

UPwards Employment Program

UPwards provides a comprehensive range of vocational rehabilitation services including career counseling, job training, internships, and referrals to educational programs. Job placement and retention services are available to men and women whose histories of chronic homelessness may have created barriers to employment.

Moving On Initiative

For many residents, our supportive housing completes their journey. Others have developed the skills and stability they need to live with greater independence and can participate in our **Moving On Initiative**. "Moving On" supports individuals as they move from supportive housing to their chosen community and neighborhoods. With our support, and that of the Corporation for Supportive Housing (CSH) and Robin Hood, residents can successfully make the transition to more independent living.

Client Advocacy Program

Urban Pathways' advocacy work addresses issues that affect our clients – services for the homeless, affordable housing, mental health and substance abuse treatment, and issues affecting the nonprofit sector. At monthly meetings, client advocates discuss events and legislation that influence their lives. Client advocates share their stories with elected officials on trips to Albany and attend local events to address issues of concern. **Client advocacy at Urban Pathways** focuses on empowerment, which brings the voices of the homeless into the conversation.

Since 1975,

Urban Pathways has engaged New York City's most vulnerable residents — homeless men and women who live with mental illness and/or substance use disorders — and helped them find **"a way home."**

While many programs offer temporary refuge to unsheltered men and women, Urban Pathways provides long-term solutions to ensure that the individuals we serve do not re-enter the shelter system or return to the streets. With the investment and support of concerned individuals and corporate and foundation partners, we provide housing and support to these men and women on their journey toward stability and permanent housing.


